Section 2 - Hazards Identification

Statement of Hazardous Nature

This product is classified as: Xi, Irritating. Hazardous according to the criteria of ASCC.

Emergency Overview

Physical Description & colour: Pink liquid.

Odour: Mild odour.

Major Health Hazards: No major health hazards. This product is classified as an eye irritant.

Potential Health Effects

Inhalation:

Short term exposure: Available data indicates that this product is not harmful. However product may be mildly irritating, although unlikely to cause anything more than mild transient discomfort.

Long Term exposure: No data for health effects associated with long term inhalation.

Skin Contact:

Short term exposure: Available data indicates that this product is not harmful. It should present no hazards in normal use. However product may be mildly irritating, but is unlikely to cause anything more than mild discomfort which should disappear once contact ceases.

Long Term exposure: No data for health effects associated with long term skin exposure.

Eye Contact:

Short term exposure: This product is an eye irritant. Symptoms may include stinging and reddening of eyes and watering which may become copious. Other symptoms may also become evident. If exposure is brief, symptoms should disappear once exposure has ceased. However, lengthy exposure or delayed treatment may cause permanent damage.

Long Term exposure: No data for health effects associated with long term eye exposure.

Ingestion:

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The ASCC TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak "is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

Section 4 - First Aid Measures

General Information:

You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 1126 from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this MSDS with you when you call.

Inhalation: First aid is not generally required. If in doubt, contact a Poisons Information Centre or a doctor.

Skin Contact: Irritation is unlikely. However, if irritation does occur, flush with lukewarm, gently flowing water for 5 minutes or until chemical is removed.

Eye Contact: Immediately flush the contaminated eye(s) with lukewarm, gently flowing water for 20 minutes or until the product is removed, while holding the eyelid(s) open. Take care not to rinse contaminated water into the unaffected eye or onto the face. Obtain medical attention immediately. Take special care if exposed person is wearing contact lenses.

Ingestion: If swallowed, do NOT induce vomiting. Wash mouth with water and contact a Poisons Information Centre, or call a doctor.

Section 5 - Fire Fighting Measures

Fire and Explosion Hazards: There is a slight risk of an explosion from this product if commercial quantities are involved in a fire. Vapours from this product are heavier than air and may accumulate in sumps, pits and other lowlying spaces, forming potentially explosive mixtures. They may also flash back considerable distances.

Only small quantities of decomposition products are expected from this products at temperatures normally achieved in a fire.

Fire decomposition products from this product may be toxic if inhaled. Take appropriate protective measures.

Extinguishing Media: Preferred extinguishing media are carbon dioxide, dry chemical, foam, water fog.

Fire Fighting: If a significant quantity of this product is involved in a fire, call the fire brigade.

Flash point: Not flammable. Note however that isopropanol will evaporate from this product and form flammable and potentially explosive atmospheres above this product if heated. Once the isopropanol has evaporated, the remaining liquid will act as an extinguishing agent..

Upper Flammability Limit:Does not burn.Lower Flammability Limit:Does not burn.Autoignition temperature:Does not burn.Flammability Class:Does not burn.

Section 6 - Accidental Release Measures

Accidental release: In the event of a major spill, prevent spillage from entering drains or water courses. Wear full protective clothing including eye/face protection. All skin areas should be covered. See below under Personal Protection regarding Australian Standards relating to personal protective equipment. Suitable materials for protective clothing include rubber, PVC. Eye/face protective equipment should comprise as a minimum, protective goggles. If there is a significant chance that vapours or mists are likely to build up in the cleanup area, we recommend that you use a respirator. Usually, no respirator is necessary when using this product. Conditions to Avoid: This product should be kept in a cool place, preferably below 30°C.

Incompatibilities: No particular Incompatibilities.

Fire Decomposition: Only small quantities of decomposition products are expected from this products at temperatures normally achieved in a fire. Carbon dioxide, and if combustion is incomplete, carbon monoxide and smoke. Water. Carbon monoxide poisoning produces headache, weakness, nausea, dizziness, confusion, dimness of vision, disturbance of judgment, and unconsciousness followed by coma and death.

Polymerisation: This product will not undergo polymerisation reactions.

Section 11 - Toxicological Information

OTHER DATA: Some very rare cases of skin hypersensitivity to Isopropanol have been reported. However, these cases do not at this time warrant Isopropanol to be classed as a sensitiser.

Section 12 - Ecological Information

This product is biodegradable. It will not accumulate in the soil or water or cause long term problems.

Isopropanol:

Biodegradation: 58% theoretical BOD, 5 days at 20° C - Relatively biodegradable.

Bioconcentration: Not expected to bioaccumulate in aquatic organisms based on low octanol/water partition coefficient.

Acute Toxicity (fathead minnow): LC₅₀ 10.4 g/L /96 hr.

Section 13 - Disposal Considerations
