4. FIRST AID MEASURES

For advice, contact a Poisons Information Centre (Phone eg. Australia 131 126; New Zealand 0 800 764766) or a doctor.

Inhalation:	Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. If patient finds breathing difficult and develops a bluish discolouration of the skin (which suggests a lack of oxygen in the blood - cyanosis), ensure airways are clear of any obstruction and have a qualified person give oxygen through a face mask. Apply artificial respiration if patient is not breathing. Seek immediate medical advice.
Skin Contact:	Wipe excess material from skin with a clean rag or paper towel (do NOT use solvent to clean skin). If skin contact occurs, remove contaminated clothing and wash skin with running water. If irritation occurs seek medical advice.
Eye Contact:	If in eyes, wash out immediately with water. In all cases of eye contamination it is a sensible precaution to seek medical advice.
Ingestion:	Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water. Seek medical advice.
Medical attention and special treatment:	Treat symptomatically.

7. HANDLING AND STORAGE

Precautions for safe handling: Avoid skin and eye contact and breathing in vapour. May form flammable vapour mixtures with air. - **Ingestion:** Swallowing can result in nausea, vomiting and central nervous system depression. If the victim is showing signs of central system depression (like those of drunkeness) there is greater likelihood of the patient breathing in vomit and causing damage to the lungs. Swallowing can result in the generation of uncomfortable quantities of carbon dioxide gas in the stomach.
- Eye contact: May be an eye irritant.
- **Skin contact:** Contact with skin may result in irritation. Will have a degreasing action on the skin. Repeated or prolonged skin contact may lead to irritant contact dermatitis.
- **Inhalation:** Material may be irritant to the mucous membranes of the respiratory tract (airways). Breathing in vapour can result in headaches, dizziness, drowsiness, and possible nausea. Breathing in high concentrations can produce central nervous system depression, which can lead to loss of co-ordination, impaired judgement and if exposure is prolonged, unconsciousness.
