## 2. HAZARDS IDENTIFICATION

This material is hazardous according to criteria of Safe Work Australia; HAZARDOUS SUBSTANCE.

Classified as Dangerous Goods by the criteria of the Australian Dangerous Goods Code (ADG Code) for Transport by Road and Rail; DANGEROUS GOODS.

## 4. FIRST AID MEASURES

For advice, contact a Poisons Information Centre (e.g. phone Australia 131 126; New Zealand 0800 764 766) or a doctor.

#### Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. If patient finds breathing difficult and develops a bluish discolouration of the skin (which suggests a lack of oxygen in the blood cyanosis), ensure airways are clear of any obstruction and have a qualified person give oxygen through a face mask. Apply artificial respiration if patient is not breathing. Seek immediate medical advice.

#### **Skin Contact:**

Wipe excess material from skin with a clean rag or paper towel (do NOT use solvent to clean skin). Remove contaminated clothing and wash skin with running water. If irritation occurs seek medical advice.

#### **Eye Contact:**

If in eyes, hold eyelids apart and flush the eye continuously with running water. Continue flushing until advised to stop by a Poisons Information Centre or a doctor, or for at least 15 minutes.

#### Ingestion:

Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water. Never give anything by the mouth to an unconscious patient. Seek medical advice. Get to a doctor or hospital quickly.

#### Medical attention and special treatment:

Treat symptomatically.

## 5. FIRE FIGHTING MEASURES

#### Hazards from combustion products:

Highly flammable liquid. On burning will emit toxic fumes, including those of oxides of carbon.

## 6. ACCIDENTAL RELEASE MEASURES

### **Emergency procedures:**

If contamination of sewers or waterways has occurred advise local emergency services.

#### Methods and materials for containment and clean up:

SMALL SPILLS: Slippery when spilt. Avoid accidents, clean up immediately. Wipe up with absorbent (clean rag or paper towels). Allow absorbent to dry before disposing with normal household garbage.

LARGE SPILLS: Shut off all possible sources of ignition. Clear area of all unprotected personnel. Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Use a spark-free shovel. If contamination of sewers or waterways has occurred advise local emergency services. Collect and seal in properly labelled containers or drums for disposal.

### 7. HANDLING AND STORAGE

This material is a Scheduled Poison S5 and must be stored, maintained and used in accordance with the relevant regulations.

#### Conditions for safe storage:

Store in cool place and out of direct sunlight. Store away from sources of heat or ignition. Store away from oxidising agents. Store away from foodstuffs. Keep containers closed when not in use - check regularly for leaks.

### Precautions for safe handling:

Avoid skin and eye contact and breathing in vapour. Keep out of reach of children. May form flammable vapour mixtures with air. All potential sources of ignition (open flames, pilot lights, furnaces, spark producing switches and electrical equipment etc) must be eliminated both in and near the work area. Do NOT smoke. Vapour may travel a considerable distance to source of ignition and flash back.

STEL (Short Term Exposure Limit) - the average airborne concentration over a 15 minute period which should not be exceeded at any time during a normal eight hour work day. According to current knowledge this concentration should neither impair the health of, nor cause undue discomfort to, nearly all workers.
